

Save North Korea Refugees Day Report 2023 Organized by the North Korea Freedom Coalition Activists Worldwide Call on Xi Jinping: Stop Repatriating North Koreans



Dear Friends:

Despite many years of advocacy and worldwide attention by so many of you, it was devastating to learn that China has started the repatriation of children, women, and men back to North Korea. It is unclear if the entire 2,600 that have been detained since COVID have all been sent back or if only half of them have been forcefully repatriated in groups of hundreds, but this advocacy must continue.

Even though it is extremely discouraging, we must continue this work and we should reflect on some significant developments that have resulted from <u>your efforts</u> as advocates for the North Korean refugees:

First, the UN Special Rapporteur, Elizabeth Salmon, and three UN working groups have spoken out strongly on this issue as well as the Special Envoys for South Korea, Ambassador Shin-wha Lee, and the United States, Ambassador Julie Turner: https://www.ohchr.org/en/press-releases/2023/10/china-must-not-forcibly-repatriate-north-korean-escapees-un-experts

Second, Xi Jinping and the CCP in China know that what they are doing is wrong, and they know the world is watching. Hence, the reason they are trying to do this quietly because of your success in raising awareness of this crisis.

Third, this will continue to be an issue until the tyranny of the communist regimes in North Korean and China end.

Fourth, never underestimate the power of your actions and your words even if it sometimes seems in vain. I have shared this with many of you before but I had thought about how hopeless it all seemed until I met three different individuals: two North Korean women who had been victims of trafficking who had contemplated suicide and one South Korean man who had been beaten and tortured in jail in China. When they heard that people like you were standing up for them, it gave them the hope to live, to survive. You gave them the will to continue because they knew they were not suffering unknown and alone.

So, we pause briefly here for a moment with this report prepared for you by Johnny Park as we thank and show our great respect to the folks listed in these pages who raised their voices against great evil to be a voice for those who could not speak.

The fight goes on.

and sisters until the day when North Koreans will




Figure 4. Kato Hiroshi




Figure 5. The PRC Embassy in Lilongwe

There is a private security company that patrols the Embassy of China. Anyone accessing the premises must have an access permit. Hence, my awareness campaign can only the next street after the embassy. China is very worried about its public image across Africa. Hence, they take strong security measures to counter all forms of human rights campaigns".

As part of the 20th North Korea Freedom Week, the Save North Korean Refugees Day 2023 protest was held at the PRC Embassy in Seoul. Over 200 people, including North Korean defectors, South Korean activists, South Korean private citizens, and the U.S. and Japanese delegations participated

At the protest, multiple prominent North Korea human rights activists raised their voices to urge the PRC to stop its gruesome practice of the forced repatriation of the North Korean refugees.

The participants at the protest requested the PRC to provide safe passage to the North Korean refugees to South Korea and reaffirmed their commitment to standing with the North Korean refugees until they can enjoy freedom. "These people (North Korean defectors) who are with us today are freedom fighters. Some of them lost their children or family members on their journey to freedom. We should never stay silent for these people," said Mr. Huh Kwang-il, Chair of the Committee for the Democratization of North Korea.

Suzanne Scholte, Chair of the North Korea Freedom Coalition, had an interview with Channel A on the issue of the forced repatriation of North Korean refugees.

After the protest, **some of the North Korea human rights activists** and **Suzanne** hand-delivered a letter to the PRC Embassy in **Seoul** asking it to stop forcibly repatriating the North Korean refugees to North Korea.

California: Some North Korea Freedom Coalition members reside in California participated in the 2023 Save North Korean Refugees Day and delivered the NKFC appeal to the PRC General Consulates in their region. Sam Kim and Rand Millar of the Korean Church Coalition for North Korea Freedom represented Los Angeles and Maria Cartwright represented Sacramento. Rand Millar commented: "The petition we will seek to hand-deliver to the consular staff at 443 Shatto Place tomorrow about noon. If that does not work, then per plan B we will mail it. It is conceivable that by then we may have gathered an additional page of signatures. Best for a strong finish to your week in Seoul!"

Chicago: Sally Jo Messersmith, a member of the North Korea Freedom Coalition, delivered the NKFC appeal to the PRC General Consulate in Chicago. Sally Jo

commented: "I went to the Chinese embassy. They were closed but I put my letters, that were signed by about 75 other individuals between the two letters, into the mailbox. We met with Grayson and Grace and her family at the Tribune Tower. We worshiped and prayed and handled our information to many individuals. The presence of God was very strong. I really felt like I made new friends. The opportunity to bring awareness concerning North Korean Refugees to 100's of people from all over the world was a dream come true. I engaged in some in depth conversations with a few individuals. I asked Seth Palmer to accompany me. He is a missionary friend to Africa who is like a little brother to me. We rode the subway in from Michigan City and not really knowing where the Chinese Embassy was at, I felt it was wise not to

go alone. I was so thankful I went and felt like I was walking in the pathway God wanted me to follow."

New York: PSALT NK helped us deliver our appeal to the PRC General Consulate in New York. PSALY NK Representative commented: "There is not much we can do at the NYC Consulate anymore. There's always a police presence there. Much has changed since the 2008 Beijing Olympics, and some of the destructive protests that took place at the time by some of the many groups impacted by the CCP's inhumane governance. Now you have NYC cops assigned to protecting the dignity of the Chinese Consulate. We also held two prayer gatherings that Friday at 9:30am and 12noon, as well as had corporate prayer meetings at 12pm - 1pm every day that week, in addition to those who signed up to pray on the prayer chain throughout the week."

Washington, DC: Pastor Star Lee of the Esther Prayer Movement and Euni Evensen, a member of the North Korea Freedom **Coalition**, organized a successful rally at the PRC Embassy in Washington D.C. and delivered our appeal. With media presence, 17 **people** participated in the rally, condemning the PRC's forced repatriation of the North Korean refugees, and marching around the PRC Embassy. Pastor Star Lee commented: "Because of the ongoing war, people's interests in over 2.000 North Korean refugees who are detained in the PRC have been waning. Approximately 600 North Korean refugees were already forcibly sent back to North Korea by the PRC. We must continue to pray for around 2,000 North Korean refugees who are still in the PRC."

On October 16th, as part of our efforts to rescue the North Korean refugees who are currently detained in the PRC, North Korea human rights activists held a rally in front of **the White House** to condemn the PRC for clandestinely sending back approximately 500 North Korean refugees to North Korea and urge the international community,

including the U.S. government, to stop the PRC's attempts to forcibly repatriate North Korean refugees back to North Korea.

South Korean National Assemblyman Thae Young-ho joined the protesters to raise his voice for the North Korean refugees in the PRC and requested President Biden to get involved in the issue. "The South Korean government alone cannot stop the forced repatriation. The American government should join the campaign and urge the Chinese government to stop it," said National Assemblyman Thae.
